 - **Digital Fingerprinting Service:** State-of-the-art technology can obtain results within days if no record is present (other methods may take upwards of five months) – for private, federal and provincial employment, for visas/foreign travel/work permits, immigration and citizenship, pardons, adoption and name changes. Ink fingerprinting services also available.
 - **Police Clearance Service** (criminal background checks, police checks, police certificates or CPIC checks): Name and date of birth-based criminal record checks – results within 48 hours if no criminal record is associated with the candidate's name and date of birth.
 - **Background Screening Service:** Education, credit and reference check services customized to meet the needs of Northern Ontario companies.
 - **Mobile Services:** Commissionaires offers mobile fingerprinting and ID services – available to travel to communities in Northern Ontario to take fingerprints or police clearance applications for VIP customers and large groups. The added convenience can save employee travel time and cost.
 - **Pardon Service:** Peace of mind during the application process – Commissionaires assists with requirements such as conducting a fingerprint-based criminal record check, acquiring court information and local police records, obtaining relevant citizenship documents or military conduct sheets, completing all required forms, and keeping customers informed at each stage of the process.
